Item Description Forecast Action By Due Date

Noise, Dust, Traffic

1.1 The residents of 70 and 80 Mill St. report that significant dust clouds are generated by the arrival of workers and trucks from before the start of work at 7:00am to 10:00am. The water truck does not arrive until 10:00am. The residents requested that watering for dust control start earlier in the day and be completed at the end of the day as well.

The residents also stated that dust is generated by activities off the travelled routes where the water truck does not go and there is dust generated by after-hours activities, and asked if those areas can be watered as well. Michelle responded that there are places the trucks can't go and Michelle areas that cannot be watered due to flooding precautions. Michelle Cain will see if anything Cain (DK) further can be done.

- 1.2 The noise exception application resulted in a "test" period. This is coming to a close and Ellis-Don City/ED has applied for an extension, but has had no approval as of yet. The request was for an extension of the Monday to Friday morning exemption, as follows:
 - Monday to Friday 6:00 am to 9:00 pm
 - Saturdays starting at 7:00 am
 - Sundays 8:00 am to 5:00 pm

No noise complaints were voiced at the meeting. Tom Davidson will investigate into the status of application.

Stormwater Tunnel Conveyance System (WT)

3.3 A section of the bike path south of the rail line and east of Cherry Street will remain closed until late 2013, with a detour in place, to facilitate the construction of the stormwater treatment building. A diversion sign was requested by Tom Davidson on the west side at Lakeshore and Cherry. A sign is already in place on the East side. Tom Davidson to follow up with Toronto Transportation then follows up with EllisDon-Ledcor.

River Street/Bayview Avenue (IO)

4.1 River Street between Queen Street and King Street opened August 20th 2012

- 4.2 A meeting will be convened with City/Corktown Residents/WT for discussions regarding a landscaping proposal for the SW corner of River and King in the next month or two.
- 4.4 The work on the 1650 Back Flow Preventer at River and King Streets will be slightly delayed to December/ January due to remedial work at the foundations of the bridge.

Cherry Street and Eastern Avenue Reconstructions (Dundee Kilmer/EllisDon)

7.1 Old Eastern Avenue

It is anticipated that Enbridge will start work on Eastern Avenue in approximately two weeks. The target date for completion of Eastern is November 2012 but may slide due to the delay in Enbridge's work.

Cherry Street

Full closure of Cherry Street from Lakeshore Blvd to Eastern Avenue will extend to 2013. Work will shut down in December 2012 and resume in Spring 2013 but Cherry may remain closed.

EDL to confirm whether Cherry Street will open from December until spring when work resumes.

Jon Goode (CRBA) previously requested that the LRT construction schedule be discussed at a future CLC meeting when the information is available as it impacts Corktown residents and businesses. Larry Webb (CRBA) reiterated the question and James Roche (WT) responded the schedule should be ready to discuss by the next meeting or following after that.

Pan-Am Athletes' Village (Dundee Kilmer/EllisDon)

8.1* EllisDon provided the following construction update:

ED

Forecast

- Block 1/14 (YMCA & GBC) work has reached grade with several concrete pours at that level complete
- Municipal Works mobilizing to start work on Toronto Hydro's permanent power system by end of month. Enbridge should be in to install gas lines as well. Street lighting foundation and conduit work continues
- Block 3 (Affordable Housing) Mass excavation complete, crane erected and under slab work complete.
- On Block 15, columns and walls poured and mechanical work started. Block 15 slab on grade work is complete.
- Block 4 (Market Housing) slab-on-grade concrete 50% complete with shoring and tieback work in excavated areas started.
- Canary Building -East shed demolition complete. The shed is an addition to the building and not of heritage or historical significance. South canopy complete.
- The approvals for underground work on blocks 3w, 4w, and 7w have reached the stage where tenders have been called. The work is expected to be complete and the blocks paved by mid-November. Residents have been complaining about high weeds around fences, due to allergies. Tim Dittmar (EDL) stated he will get them taken care of.

Block 11 has begun work.

 Existing waterline just about finished work. The last water shut down expected to happen in the next couple weeks

8.2 The residents previously advised that Dundee Kilmer's security fence behind 70 and 80 Mill Street is encroaching over the property line and impacting laneway access. Ellis Don indicated that the encroachment is very minor, and they would prefer to leave the fence in place to facilitate the construction of the asphalt parking lot on the lands to the north, which is scheduled to start this summer. This will be resolved once the underlay work and paving are complete.

Parks (WT)

9.1 Underpass Park Phase 1 is now open to the public. The City assumed the park on July 16th. There have been concerns raised by the community regarding crossing River Street from one part of the park to the other. The City is reviewing the issues and is looking into the feasibility of installing temporary signage or a stop sign. James Roche/Andrew T will continue to follow up.

9.2 Construction of Phase 2 of Underpass Park (west of St. Lawrence Street) is nearing completion. Trees, lighting and power have yet to be installed. The opening is still tracking for spring 2013.

WT

9.3 Construction of the dry side of Don River Park is complete. Minor deficiencies being addressed.

WT

Park construction on the wet side cannot begin until after the armoured slope is complete. Armoured slope underway. The current schedule for the completion of Don River Park is summer 2013.

WT noted that the park cannot be opened to the public until it is 100% complete, due to public safety concerns and limited access points.

9.4 WT to review possible opening of Lawren Harris Square in advance of the balance of Don River Park. Lawren Harris Square is being used despite efforts to restrict trespassers. Remedial work to prevent erosion is ongoing, lighting is yet to be installed and some ownership details have to be worked out, including a land conveyance. Will not open this fall. The Square will open at the same time as Don River Park.

Kusturin informed the group that Metrolinx plans to make improvements to both underpasses in advance of the Pan-Am games. Additional information will be shared as details become available.
- 13.2 On behalf of the Corktown residents, Jon Goode asked for as much advanced notice as possible regarding road closures, staging, etc., in light of concerns over how the Bayview Avenue/River Street opening unfolded.
- 13.3 Canary District condo sales centre is now open to the public at Mill and Parliament. Info
- 13.4 The committee elected to continue the WDL CLC meetings on a 6 week schedule.
