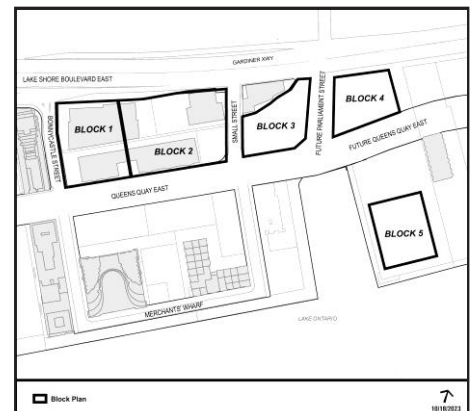

Proposal

The City of Toronto has received applications to amend the Zoning By-law at 259 Lake Shore Boulevard East (Quayside Blocks 1 and 2) and to amend the Official Plan and Zoning By-law at 333 Lake Shore Boulevard East (Quayside Blocks 3 to 5).

The applications are for a 12-storey timber building on Queens Quay East and 5 tall buildings ranging from 55- to 72-storeys along Lake Shore Boulevard East. 4,634 residential units, including 869 affordable rental housing units, are proposed, along with retail, office and institutional space and open spaces.
