- 1. Welcome and Project Update
 Chris Barre welcomed the participants and gave a brief project update.
- 3. Construction Update

Anthony Bisanti provided an overview of construction activities:

 Caisson work is now complete on the south side and will progress to the east and north side.

- The first phase of excavation will commence in two weeks and is slated to last until April. Excavation is being done to facilitate the construction of a retaining wall.
- Construction noise will stay at the current level but might slightly increase in August when excavation reaches bedrock.

4. Issues to Date

- The following incidents were noted and subsequently resolved:
 - a. Vibration report at Queens Quay Terminal resolved
 - b. Resident complaint from Queens Quay Terminal regarding trucks onsite prior to working hours also resolved
 - c. Query about work hours from 208 Queens Quay resolved
 - d. Group feedback:
 - CLC members expressed concern about maintaining street cleanliness during and after construction activity.
 - Ellis Don advised that the following measures are being implemented: 1) Mud is removed from truck tires; 2) Street-cleaning truck is sent regularly

5. Sharing Information

- Property managers will continue to post construction notices in their buildings
- Construction notices will also be posted in Waterfront Toronto newsletters

6. Permit for Extended Work Hours

 Permit application was submitted to the city. A notice will be put up once permit is approved.

7. Next steps

- The next CLC meeting will take place a few weeks after exaction work. Invitations will be sent from Waterfront Toronto to CLC members by email.
