

# Lower Yonge Precinct Transportation Master Plan

## Municipal Class Environmental Assessment Notice of Study Completion

The City of Toronto and Waterfront Toronto have completed Phases 1 & 2 (of 4) of an Environmental Assessment (EA) to identify the transportation infrastructure required to support development within the Lower Yonge Precinct. The following solutions are recommended:

- The extension of Harbour St. eastward from Yonge St. to Lower Jarvis St.
- The conversion of Harbour St. from one-way eastbound to two-way operations from York St. to Yonge St.
- The realignment of the Yonge St./Harbour St. intersection
- The shortening of the Lower Jarvis St. off-ramp from the eastbound Gardiner Expressway to touch down at Yonge St.
- The removal of the Bay St. on-ramp
- The extension Cooper St. north to connect with Church St. and The Esplanade
- The enhancement of the road network within the Lower Yonge Precinct area including the addition of New Street and various new intersection connections.

Further EA studies and approvals will be required for a number of the infrastructure components identified in the Transportation Master Plan. These further studies will define the specific roadway alignments, lane configurations, public realm composition, and other technical aspects.

### Opportunities for Review

The Lower Yonge Precinct Transportation Master Plan has been placed on public record for a 30-day review period starting May 21, 2015 and ending June 22, 2015. It will be available for review at the following locations:

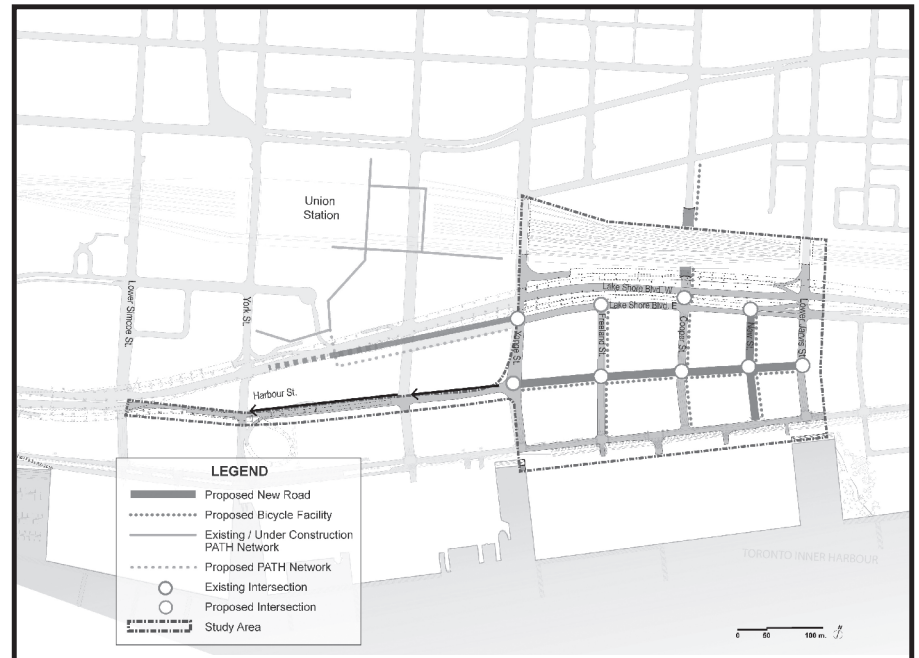
